Updates: Member updates; Relevant updates from related groups and sub-national AAP updates and Workstream updates The following updates were provided Humanitarian Communication Group: HCG held a meeting on 15 October in which they mainly discussed about draft ToR for the group. The objective of the working group will focus on public communication highlighting the impact of crisis on daily lives of people. The ideas of public communication will be updated to complement the public advocacy undertaken by HC and HCT members. Additionally, Senior Protection Advisor provided the presentation on HCT Protection Strategies focused mainly on public communication. It was added that there should be more linkage between AAP/CE WG and HCG WG. Rakhine Accountability Quality Assurance/ WASH cluster: AQA WG updated that they have regular meetings to discuss on key indicators to be included in monitoring system and database. Additionally, there will be a meeting to discuss on WASH service models for AAP. Global WASH cluster provided their support in order to build the database dashboard.
