OCHA provided an update on resource mobilization and MHF standard allocation. In terms of recruiting AAP specialist who will be fully dedicated to strengthening AAP within humanitarian response, the process is going on well. Meanwhile, the working group have received a few profiles of the possible candidates. In terms of MHF allocation, one partner has submitted a proposal which has gone through the first strategic review and will move forward to the technical review stage. Hopefully, the technical review will be done within a week. Then, HC will give approval for the project submitted.

4. 2023 Workplan – Overview of inputs

Co-chair presented and provided a brief overview on inputs discussed on 2023 Workplan. . Members have already provided the inputs from their sides all of which will be integrated into the existing workplan. The updated workplan will hopefully be finalized in early 2023.
