The Programme constitutes a follow-up to and builds on the country-led NES process. The Programme provides direct support to sector value chains to stimulate job creation, poverty alleviation and rural development; reinforces trade support institutions to increase exports; and supports the country's NES implementation and management.

One of the Country Programme components i.e. support to one priority sector value chain – Inclusive Tourism in Kayah State – is funded by the Netherlands/Centre for Import Promotion to the Netherlands (CBI), and implementation will start in September 2014. The three-year project aims to enhance trade competitiveness of the tourism sector by integrating local producers and service providers into the tourism
