Situation Report – 156

Data as received by WHO from national authorities by 10:00 CEST, 24 June 2020

Highlights

<u>Mr Bean has joined the war against COVID-19!</u> A cartoon has been developed by WHO in partnership with Project Everyone and Tiger Aspect Productions, to remind the public to continue to take precautions to prevent COVID-19 infection and spread.

<u>23 June marked Olympic Day</u>. This year, the International Olympic Committee and WHO, together with the United Nations, launched a partnership to encourage individuals and communities around the world to be <u>#HEALTHYTogether</u>.

WHO has released a scientific brief on <u>Breastfeeding and COVID-19</u> examining the evidence of the risks of transmission of COVID-19 from an infected mother to her baby through breastfeeding, as well as evidence on the risks to child health from not breastfeeding. WHO recommends that mothers with suspected or confirmed COVID-19 should be encouraged to initiate or continue to breastfeed.

Today's '<u>Subject in Focus</u>' provides an update on WHO's work at securing and shipping COVID-19 supplies, including personal protective equipment, diagnostics kits, and biomedical equipment.

Subject in Focus: COVID-19 Supply Chain System – Progress Update

Personal Protective Equipment (PPE)

Through the PPE purchasing consortium, WHO has secured large volumes of equipment that are being shipped to 135 countries in the coming weeks. A total of more than 239 million items – comprising 141 million PPE procured by WHO and a donation by the Jack Ma Foundation of 100 million medical masks and 1 million N95 respirator masks – have been allocated to all WHO regions and are being shipped in the coming weeks

Recent discussions with 54 private sector organizations addressed issues related to quality assurance of PPE, which continues to be of major concern to manufacturers, buyers and governments. They urge WHO to advocate at the highest levels to ensure that counterfeit and low-quality products are not sold in the market. WHO and purchasing consortia partners continue to engage with suppliers to ensure that all goods procured by WHO and consortia partners meet quality assurance standards.

Diagnostics

WHO has procured 4.5 million polymerase chain reaction (PCR) tests through the diagnostics purchasing consortium. Tests are being produced and packed by suppliers for shipment in the coming weeks. As of 15 June, 585 830 tests have been shipped to 10 countries.

WHO has also procured 4.8 million sample collection kits, of which 1.04 million kits are ready to ship. As of 15 June, 114 000 sample kits have been sent to 29 countries.

The United Nations Children's Fund (UNICEF) has procured 298 000 tests, of which 123 000 have been shipped to 18 countries.

Biomedical Equipment


Following an initial procurement of 4000 oxygen concentrators, WHO has purchased an additional 10 000 oxygen concentrators, 9800 pulse oximeters and consumables (estimated total value: USD 10 million), which will be distributed to more than 120 countries. To date, 2000 oxygen concentrators have been shipped, and 2000 are in transit.

COVID-19 Supply Portal

So far, 48 countries have submitted requests for supplies valued at more than USD 92 million through the COVID-19 Supply Portal, an online platform WHO launched in May through which countries that need supplies for the COVID-19 response can enter requests.



Case definitions

WHO periodically updates the <u>Global Surveillance for human infection with coronavirus</u> <u>disease (COVID-19)</u> document which includes surveillance definitions.

Definition of COVID-19 death

A COVID-19 death is defined for surveillance purposes as a death resulting from a clinically compatible illness in a probable or confirmed COVID-19 case, unless there is a clear alternative cause of death that cannot be related to COVID-19 disease (e.g. trauma). There should be no period of complete recovery between the illness and death.

Annex 1: Data, table and figure notes

Caution must be taken when interpreting all data presented. Differences are to be expected between information products published by WHO, national public health authorities, and other sources using different inclusion criteria and different data cut-off times. While steps are taken to ensure accuracy and reliability, all data are subject to continuous verification and change. Case detection, definitions, testing strategies, reporting practice, and lag times differ between countries/territories/areas. These factors, amongst others, influence the counts presented, with variable underestimation of true case and death counts, and variable delays to reflecting these data at global level.

The designations employed, and the presentation of these materials do not imply the expression of any opinion whatsoever on the part of WHO concerning the legal status of any country, territory or area or of its authorities, or concerning the delimitation of its frontiers or boundaries. Dotted and dashed lines on maps represent approximate border lines for which there may not yet be full agreement. Countries, territories and areas are arranged under the administering WHO region.

The mention of specific companies or of certain manufacturers' products does not imply that they are endorsed or recommended by WHO in preference to others of a similar nature that are not mentioned. Errors and omissions excepted, the names of proprietary products are distinguished by initial capital letters.

^[1] All references to Kosovo should be understood to be in the context of the United Nations Security Council resolution 1244 (1999). In the map, number of cases of Serbia and Kosovo (UNSCR 1244, 1999) have been aggregated for visualization purposes.

Counts reflect laboratory-confirmed cases and deaths, based on <u>WHO case</u> <u>definitions</u>, unless stated otherwise (see Country, territory, or area-specific updates and errata), and include both domestic and repatriated cases.

Other*: includes cases reported from international conveyances.

Due to the recent trend of countries conducting data reconciliation exercises which remove large numbers of cases or deaths from their total counts, WHO will now display such data as negative numbers in the "new cases" / "new deaths" columns as appropriate. This will aid readers in identifying when such adjustments occur. When additional details become available that allow the subtractions to be suitably apportioned to previous days, graphics will be updated accordingly. Prior situation reports will not be edited; see <u>covid19.who.int</u> for the most up-to-date data.

Additional table notes

ⁱ Transmission classification is based on a process of country/territory/area self-reporting. Classifications are reviewed on a weekly basis and may be revised as new information becomes available. and. Differing degrees of transmission may be present within countries/territories/areas; classification is based on the highest category reported within a country/territory/area. Categories:

- No cases: with no confirmed cases
- Sporadic cases: with one or more cases, imported or locally detected
- Clusters of cases: experiencing cases, clustered in time, geographic location and/or by common exposures
- Community transmission: experiencing larger outbreaks of local transmission defined through an assessment of factors including, but not limited to: large numbers of cases not linkable to transmission chains; large numbers of cases from sentinel lab surveillance; and/or multiple unrelated clusters in several areas of the country/territory/area
- Pending: transmission classification has not been reported to WHO

ii "Territories" include territories, areas, overseas dependencies and other jurisdictions of similar status.

Country, territory, or area-specific updates and errata

- Erratum 24 June 2020, Ecuador: The original publication of the 23 June Situation Report excluded 275 additional cases and 23 deaths. Counts have been corrected.
- Update 24 June 2020, Switzerland: Counts adjusted retrospectively by national authorities: 1 death has been excluded.
