



# Country Monitoring, Evaluation, Accountability, and Learning (MEAL) Coordinator

## National Position

Malteser International (MI) is the international humanitarian relief agency of the Sovereign Order of Malta. For over 60 years we provide relief and recovery for people during and following conflicts and disasters around the world. Christian values and humanitarian principles form the foundations of our work. Our work aims at ensuring communities having access to primary health care services. MI strives to enable and empower the most vulnerable communities in marginalized areas through a participatory and sustainable approach.

**In support of the work in Yangon, Myanmar, Malteser International is looking for a motivated Country Monitoring, Evaluation, Accountability and Learning (MEAL) Coordinator – (m/f/d) - National Position.**

As the Country MEAL Coordinator, your pivotal role includes to develop and oversee the implementation of a comprehensive monitoring, evaluation, and accountability (MEAL) framework for the projects, ensuring standardized data management, evidence generation, and research coordination to support effective program learning, reporting, and impact assessment across Malteser International programs and projects in the Country. Under the direct supervision of the Country Program Coordinator (CPC), you will be instrumental in overseeing and elevating the success of these initiatives.

## Your responsibilities:

### I. General

- Provide strategic leadership and direction in the review, development and implementation of a harmonized monitoring, evaluation and accountability framework of the project and oversee its implementation across the targeted projects.
- Update and support the implementation of an effective and coordinated Monitoring, Evaluation, Accountability and Learning (MEAL) framework and system of the Myanmar Country Program in a service-oriented manner.
- Develop capacity of staff and partners on the Monitoring, Evaluation, Accountability and Learning (MEAL) framework, data management, data analysis and results-oriented programming, monitoring and evaluation methods and principles. Close cooperation is also desired with the program locations as well as countrywide projects personnel.
- Introduce the Monitoring, Evaluation, Accountability and Learning (MEAL) framework to staff (including new staff as part of the induction)
- Ensure record-keeping and storage of data and information.
- Maintain working relationships with monitoring and evaluation (M&E) counterparts in other relevant international and local Non-Government Organizations (NGOs) in Myanmar, Malteser International country programs elsewhere and the Quality Assurance Department of Malteser International Headquarter in Germany (via the Program Managers in Cologne).



- Review project Monitoring, Evaluation, Accountability and Learning (MEAL) and progress reports, consolidating them for analysis and reporting.
- Organize and/or facilitate MEAL-related training for MI and partner organizations.

## **II. Monitoring and Evaluation**

- Provide hands on technical assistance by ensuring a consistent approach that enables standardized procedures of data collection, analysis, feedback and reporting by the project team including those of partners.
- Support the location's project and Monitoring, Evaluation, Accountability and Learning (MEAL) personnel in setting up, understanding, and implementing Monitoring, Evaluation, Accountability and Learning (MEAL) plans, including Indicators Performance Tracking Tables (IPTT) and data collection tools for all projects and programmes.
- Manage MEAL-related consultancies, such as base- and endline surveys, case studies, evaluations; integrates technical input of technical coordinators and CPC when applicable. Carry responsibility for storing consultancy outputs.
- Support the country program and partners in the application of innovative methods and tools (for example Kobo collect) and ensures the maintenance and continuous improvement of Kobo-based data collection and analysis.
- Support locations directly in carrying out data analyses.
- Quality assurance of location survey designs and tools with input from Country Program Coordinator (CPC) and technical coordinators.
- Work with staff to improve the use of qualitative data collection tools, e.g. People First Impact Method (P-FIM), Focus Group Discussions (FGDs) and others.
- Evaluate other evaluation methods, e.g. Resilience Star, for its application in certain project settings, e.g. eastern Shan State.
- Oversee the baseline, mid-term, and endline evaluations for projects.

## **III. Generation of Evidence, Learning and Accountability**

- Lead the coordinating and documentation of project learning and evidence generation for key internal and external audiences, including for donor reporting, advocacy work and visibility measures as required.
- Identify lessons learned and best practices from previous program/project implementation and evaluations and actively promotes learning through documentation and sharing of lessons learnt by means that promote active learning, i.e. review workshops and similar.
- Work with technical coordinators, Country Program Coordinator, countrywide project, and program location teams to ensure that lessons learned, and best practices are incorporated into the design of new projects/programs.
- Support locations to establish functional and practicable Community feedback and response mechanisms (CFRM) in line with MI standards. Assists locations to analyse and adapt Community feedback and response mechanisms (CFRM).
- Follow up on People First Impact Method (P-FIM) as assessment and Monitoring and Evaluation (M&E) tool and training of staff on People First Impact Method (P-FIM) in coordination with People First Impact Method (P-FIM) practitioners. Identify ways to use it as an evaluation tool.
- Establish training and multiplication calendar for staff that received trainings.
- Ensure the gender, age, and disability inclusion (GADI) is taking into consideration in all project proposals and MEAL-related activities.
- Lead the project learning workshop with the project coordinators.
