1. BACKGROUND

BRIEF PRESENTATION OF THE PROJECT

Médecins du Monde-France (MdM-F) is an international humanitarian organization whose mission is to provide medical care for the most vulnerable populations, the world over, including France. It aims to enlist the support of health care providers and experts from other relevant fields, ensuring all necessary competencies are engaged in its projects, while consistently fostering close working relationships with the populations it serves.

MdM-F has been operating in Myanmar since 1994. Its main program delivers comprehensive Harm Reduction and HIV/AIDS prevention and care, focusing on key populations – People who Use Drugs (in Kachin State), and Female Sex Workers and LGBTQI+ (in Yangon). In Kachin, MdM-F's programs are implemented in 2 main sites (Moegaung and Hopin/Mohnyin). Activities include health-education in outreach, needles and syringe exchange program, methadone substitution program, counselling and HIV testing, and medical care for People living with HIV (STI, opportunistic infections, Tuberculosis and ARV).

In addition, MdM-F is launching a new three-year project titled "Collective Actions and Social Change for Comprehensive Harm Reduction Among Key Populations in Myanmar." The project aims to improve access to harm reduction and SRH services and strengthen the resilience of targeted beneficiaries – FSW), Men who have Sex with Men (MSM), and Transgender Women (TGW). The project will be implemented in partnership with 3 local organizations in four main regions of Myanmar – Yangon, Mandalay, Bago, and Ayeyarwady. The project will support and scale up the delivery of and access to comprehensive harm reduction services and SRH services.

Aiming to scale up MdM-F's scope of interventions on SRHR in Myanmar and effectively address emerging SRH issues of the targeted populations (especially, female sex workers, females living with HIV, and other vulnerable women and young girls), this consultancy announcement intends to ensure the technical capacity of its staffs in delivering SRH medical/clinical services including but not limited to cervical cancer screening and thermal intervention for pre-cancerous lesion, family planning, post/safe abortion care, STIs treatment and primary and referral case management for GBV survivors.



2. DEFINITION OF THE CONSULTANCY MISSION

OBJECTIVE

In the context of this project, MdM-F is looking for a consultant at Yangon (Myanmar) to carry out a **SRHR training**, the objective of which is to conduct a comprehensive training and practical session to build the technical capacity of project medical/paramedical staff in delivering SRH medical/clinical services among others cervical cancer screening and thermal intervention, family planning, post/safe abortion care, STIs treatment and case management for GBV survivors.

The scope involves, but not limited to:

- Facilitating the participatory training on theoretical/technical background of identified SRH medical/clinical scope of services
- Coaching the staff in practical clinical procedure through hands-on sessions, for the first few cases until the staff get confidence and be familiar with the procedure.

3. PROFILE SOUGHT

The skills required for the mission are:

- 1. Proven professional and technical experience of clinical practice in obstetric and gynaecologic including cervical cancer screening and thermal intervention, implant insertion/removal, post abortion management, STI treatment and primary care for the GBV survivors
- 2. Ideally previous experience of mentoring, coaching and training medical practitioners
- 3. Previous experience working with INGOs, public health, humanitarian sector
- 4. Mandatory to have communicable English speaking and writing skills
- 5. Previous experience of developing consultancy proposal, financial planning and training analytical report is an asset
- 6. Experience working with vulnerably populations is an added value
