Background on the recruiter :

FXB is an international organization with over 30-years of experience in breaking the cycle of poverty. Since 1989, FXB has been promoted access to fundamental rights for the most vulnerable - primarily children - fights extreme poverty and helped local populations adapt to climate change. These impacted the lives of 20 million people through our activities aimed at giving families access to basic rights and empowering local communities.

The organization currently operates in 11 countries with a team of over 400 local professionals who work hand in hand with the local communities we support.

Since 1992, FXB Switzerland has been actively promoting sustainable development and improving the living conditions of the most vulnerable communities in Myanmar, where it is registered as an international non-governmental organization.

In Myanmar the organization developed programs related to health, education, vocational training and income generating activities, organized HIV/AIDS and human-trafficking campaigns, and has undertaken emergency and reconstruction operations following floods and cyclone Nargis and earthquake. More than 300,000 children and adults have benefited from FXB's presence in their communities.

Since 2020, to ensure that isolated populations living along the Irrawaddy River have access to adequate health and preventive care, two cruise ships RV-INWA and RV-MINGUN have been transformed into floating clinics. The services are provided by general practitioners, nurses, and pharmacists. The team also conducts health education and awareness campaigns, notably in sexual and reproductive health. The floating clinics currently provides quality health care, sexual and reproductive health awareness, and services in Mandalay, and Magway regions.

For Floating Clinic, FXB Myanmar is looking to hire a **Pharmacist**:

The Pharmacist is working under the supervision of the medical officer (team leader), primary responsibility is to ensure safe and effective dispensing of medications, provide patient education, and support the clinical team in delivering high-quality care.

More specifically, the pharmacist tasks include:

Dispensing Medications:

- Accurately prepare, dispense, and label medications as prescribed by the medical officer or healthcare providers.
- Verify prescriptions for accuracy and appropriateness based on patient conditions.
- Adapting to changes in medication therapies, pharmaceutical regulations, and healthcare practices is necessary to provide up-to-date and patient-centered care.

Inventory Management :

- Maintain adequate stock levels of medications and supplies.
- Conduct regular inventory checks and notify management about restocking needs or expired products.
- Ensure proper storage of medications, including temperature-sensitive drugs.

Medication Safety :

- Monitor for potential drug interactions, contraindications, or allergies.
- Implement and follow standard protocols for safe handling and dispensing.

Counseling to patients :

- Educate patients on the proper use of medications, including dosage, frequency, and potential side effects.
- Provide advice on over-the-counter drugs and lifestyle modifications where appropriate.
- Address patient questions or concerns regarding their medications.

Medication Adherence:

- Encourage and assist patients in adhering to their treatment plans.
- Identify and resolve barriers to medication compliance, such as cost or misunderstandings.

Team Coordination

- Work closely with the medical officer to ensure medications prescribed align with treatment plans.
- Provide insights on drug choices, cost-effective alternatives, or new treatment options.
- Assist nurses and other team members by providing guidance on drug administration and storage.
- Support the team during health campaigns, vaccinations, or other clinic programs.

Documentation and Reporting

- Maintain accurate records of dispensed medications and inventory.
- Ensure compliance with legal and regulatory standards for pharmacy practice.
- Report adverse drug reactions or medication errors to the appropriate authority.
- Prepare and submit required reports, such as controlled substance usage, to regulatory agencies.

Quality and Safety

- Regularly review patient medication profiles to identify and prevent potential issues.
- Ensure all medications meet quality standards and are safe for patient use.
- Follow hygiene and infection prevention protocols in the pharmacy area.
- Educate patients about safe handling and disposal of medications.

Professional Development

- Keep current with advancements in pharmacology, drug formulations, and treatment guidelines.

- Attend training sessions, workshops, and seminars as recommended by the clinic or team leader.
- Provide feedback to the medical officer or clinic manager on how to improve pharmacy-related workflows.
- Assist in the preparation of emergency medication kits and ensure they are always stocked.
- Respond promptly to urgent requests from the medical officer or clinical team during emergencies.
- Participate in health education or outreach programs to promote safe medication use.

Qualifications :

- Prefer a degree of Pharmacy or recognized degree from university.
- 2 years of experience as a pharmacist, with a background in dispensing medications, conducting medication therapy management, and collaborating with healthcare professionals, is highly valued
- In-depth knowledge of medications, drug interactions, dosage forms, and pharmaceutical regulations is crucial for accurate dispensing and counseling on medication use.
- Strong communication skills are essential for interacting with patients, healthcare professionals, and other healthcare team members. Clear communication is also necessary for providing medication education and counseling
- Proficiency in using pharmacy management software, medication databases, and other technology tools is crucial for efficient and accurate dispensing and recordkeeping
