

## Cluster objectives and activities:

CO1: Implemented, operated and sustained quality and standards of water and sanitation services and good hygiene practices to crisis affected population to maintain the health, dignity and protection of the affected population, on the basis of risk-sensitive programming and consultation with communities for integrated/mainstreamed WASH services.

CA1: Crisis-affected people including IDP's returnees, stateless and other vulnerable groups have equitable, inclusive and safe access to safe/improved drinking water meeting demand for domestic purposes, at minimum/agreed standards.

CA2: Crisis- affected people including IDPs, returness, stateless and other vulneraberal groups have equitable, inclusive and safe access to functional excreta disposal systems.

CA3: Crisis-affected people including IDP's returnees, stateless and other vulnerable groups have equitable, inclusive and safe access to community-tailored messages, enabling health seeking behavior.

CA4: Crisis-affected people including IDP's returnees, stateless and other vulnerable groups in temporary learning have access to integrated/mainstreamed WASH services.

CA5: Crisis-affected people including IDP's returnees, stateless and other vulnerable groups in temporary health facilities have access to integrated/mainstreamed WASH services.

CA6: Crisis-affected people have access to integrated/mainstreamed WASH services in emergencies, on the basis of risk-sensitive programming and consultation with communities.

CA7: Crisis-affected people including IDP's returnees, stateless and other vulnerable groups have equitable, inclusive and safe access to hygiene items.

CO2: Cluster coordination and information management are strengthened at all levels.

CA8: Eight Cluster Coordinators (two for each geographical coordination zone including co-coorindator and two at national level) and five Cluster Information Management Officers.
