It is a local non-governmental organization in Myanmar and is established in particular to advance socially beneficial purposes in Myanmar by promoting and providing information, services and products related to the prevention, promotion, curation and rehabilitation of the major health services including but not limited to HIV/AIDS, malaria, tuberculosis, maternal and child health, reproductive health and non-communicable diseases with the aim of furthering good health, prosperity and the relief of poverty, distress and sickness. This also includes state-of-art training programs, quality assurance programs, and a robust supply chain and logistics system and health financing mechanisms. The Organization may also provide non-health related ancillary services that ensure and improve the well-being of its clientele.

SCH is practicing the right to freedom from all forms of sexual violence, injustice, discrimination and abuse (including child and adult at-risk abuse). JOB SUMMARY:

The **Response Coordinator** plays a critical role in planning, coordinating, and leading SCH's emergency response activities in Mandalay and surrounding regions. The position is responsible for managing field-level emergency assessments and interventions, while also ensuring strategic alignment through coordination with local partners, private donors, public donors, and relevant authorities. The coordinator will serve as a key representative for advocacy, planning, execution, and reporting to stakeholders.

KEY RESPONSIBILITIES:

The key responsibilities of **Response Coordinator** include:

- 1) Rapid Assessment & Response Coordination
 - Lead field assessments in crisis-affected areas to identify urgent humanitarian needs.
 - Coordinate with SCH teams on routine grants, local partners, and humanitarian clusters to design and implement response strategies.

2) Operational Management

- Develop and manage rapid response work plans and budgets in alignment with SCH protocols.
- Oversee procurement and logistics to ensure the rapid deployment of supplies and services.

3) Partnership & Coordination

- Liaise with local authorities, civil society organizations (CSOs), and UN/INGO networks to align and coordinate emergency efforts.
- Represent SCH in humanitarian coordination forums, relevant cluster meetings, and with private/public donors as needed.

4) Monitoring, Evaluation & Reporting

- Monitor the effectiveness, efficiency, and accountability of SCH's emergency interventions.
- Prepare timely situation reports, operational updates, donor communications, and contribute to advocacy documentation.

5) Capacity Building

• Facilitate training sessions and ongoing support for SCH field teams and partners on emergency preparedness and response protocols.

QUALIFICATIONS AND EXPERIENCE

- University degree in public health, humanitarian affairs, development, or a related field.
- Minimum of 3 years' experience in emergency response, preferably in conflict or disaster-affected settings.
 Proven coordination, communication, and project management skills.
- Experience working with NGOs, UN agencies, and/or government coordination mechanisms.
- Willingness to travel frequently and work in high-pressure or austere environments.

CORE COMPETENCIES

- Proactive, solution-oriented, and results-driven approach.
- Strong interpersonal and cross-cultural communication skills.
- Ability to make sound decisions under pressure.
- Commitment to humanitarian principles and SCH's core values.
- Awareness and understanding of safeguarding, Protection from Sexual Exploitation and Abuse (PSEA), and Do No Harm principles.

WORKING CONDITIONS

- Based in Mandalay with frequent field travel to affected regions.
- Flexibility to work outside of regular hours, particularly during emergencies or rapid response deployments.
