This also includes state-of-art training programs, quality assurance programs, and a robust supply chain and logistics system and health financing mechanisms. The Organization may also provide non-health related ancillary services that ensure and improve the well-being of its clientele.

JOB SUMMARY:

Medical Doctor (Mobile Team Leader) to engage in all mobile team activities. S/he is responsible for achieving the challenging targets assigned to his/her territory.

DUTIES & RESPONSIBILITIES:

The duties and responsibilities of **Medical Doctor** include:

- Co-operate with health and local administrative authorities and SCH implementation team for planning, implementation, training, management and supervision of mobile team activities
- Ensure to operate mobile team activities in accordance with approved work plan and to achieve the targeted number of assigned projects.
- Provide SRHR, MNCH, GBV services according to guidelines and in line with project objective.
- Supervise mobile team staff during field operation.
- Take financial accountability and responsibility for mobile team operations according to organization rules and regulations.

- Provide project consumption of necessary stocks as per mobile team schedules in monthly to supervisors by using standardized format.
- Review and check data regarding mobile team activities and submit mobile team reports monthly to supervisors by using standardized format.
- Organize quarterly review meetings in respective project township and participate in the project review meetings if necessary.
- Regular monitoring/supportive visit to all assigned Sun clinics in assigned area to distribute social franchising products, to deliver new updated forms, to collect MCRs, financial transaction of provider's incentive payment, Clinic assistance fees and client's incentive.
- Assist Sun providers to meet social franchising and clinical practice minimum criteria
- Conducting advocacy, area mapping, & clinic auditing for new recruitment for channels in the assigned territory
- Responsible for disseminating technical updated and changes to Sun providers in assigned territory
- Perform any other additional duties as required.
