Job purpose

The ICRC is looking for a Protection Field Officer, to be based in its sub-delegation in Sittwe. S/he will contribute to the work of ICRC Protection Team in Rakhine, in the framework of the SIT SD plan of action. The employee will predominantly be based in SIT office and will cover different Protection tasks as described below, with the added responsibility to support the Protection department's administrative load.

Main responsibilities

- Contributes to the implementation of Protection activities under supervision of Protection Delegate and Protection Team Leader.
- Conducts field assessments either independently or as part of ICRC multidisciplinary teams focusing on the humanitarian needs of affected populations.
- Supports the Protection team in the follow up of specific individual PFL cases and carry out dissemination sessions about Protection of Family Links (PFL) services of the ICRC to different
- Supports the detention file through implementing Safe Return Home and Family Visit programs, and support in collecting and delivering Red Cross Messages as needed.
- Contributes to the assessment, analysis, and identification of priority protection issues for follow up. Prepares daily record of family visits, visitors, and phone inquiries and share them timely with the manager (s) and the Data administrator.
- Handles cash and all relevant supporting documents for the Finance Department and be responsible for opening and closing his/her own working advances according to the ICRC financial guidelines.
- Liaises with the different interlocutors and stakeholders on varying issues of interest when required.
- Contributes to the definition of the annual objectives and plans of actions of the ICRC Protection
- Monitors the political, economic, and social developments and their impact on the population.
- Prepares the operational reports and regularly gives an account of the ongoing activities including multidisciplinary assessments.
- In coordination with the Protection Delegate, identifies humanitarian needs resulting from conflict or violence and proposes a course of action.
- Supports with interpretation during meetings.
- Performs other tasks linked to Protection and Field activities, as needed.

Requirements and experience

- University degree and/or equivalent
- At least 2 years' work experience in a similar field
- Good computer proficiency especially in MS Office suite
- Fluency in both oral and written communication in English and Myanmar, good knowledge of local dialects spoken in Rakhine
- Ability to network, represent the organization externally and dialogue with major stakeholders
- Excellent administrative, time management, and organizational skills
- Upholds a high sense of accountability, professionalism, and confidentiality.
- Fosters collaboration, creativity, positivity, and flexibility in the workplace.
- Knowledge of International Humanitarian Law/International Human Rights Law, and the Red Cross Movement is an asset.
