Job purpose

The ICRC's Protection Unit is looking for a Protection Field Officer for Lashio office (temporarily based in Taunggyi) under the supervision of Field Team Leader. The Protection Field Officer is responsible for contributing to and support the implementation of protection activities in Shan State, including maintaining contact with populations affected by armed conflict, civil and military authorities, community-based organizations and local branches of the National Red Cross Society.

The Protection Field Officer contributes to the planning, implementation, monitoring and documentation of ICRC Protection and Field activities in Shan State. This is a resident/ national position based Lashio.

Main responsibilities

- Contributes to the implementation of Protection of Civilian Population (PCP) activities.
- Conducts field assessments either independently or as part of ICRC multidisciplinary teams focusing on the humanitarian needs of affected populations.
- Supports the restoring family links (RFL) team in the collect and follow up of specific individual RFL cases.
- Supports the detention file through implementing safe return home and family visit programs.
- Contributes to the assessment, analysis, and identification of protection concerns for further monitoring and follow up.
- Liaises with the different interlocutors and stakeholders on varying issues of interest and disseminates about ICRC mandate and activities.
- Monitors the political, economic, and social developments and their impact on the population within Shan State.
- Prepare the operational reports and regularly gives an account of the on ongoing activities including multidisciplinary assessments.
- Identifies, monitors and follows up on humanitarian needs resulting from conflict or violence and proposes a course of action under the guidance of the field team leader.
- Performs other tasks linked to Protection and Field activities, as needed.

Requirements and experience

- At least 2 years of experience in a similar field of activity
- Bachelor's degree in social sciences, Development Studies, Law or equivalent qualification in a related field of study (desired).
- Knowledge of International Humanitarian Law (IHL)/ International Human Rights Law and the Red Cross Movement is an asset.
- Ability to network, represent the organization externally and dialogues with major stakeholders.
- Fluency in both oral and written communication in English and Myanmar.
- Fluency in one of the other local languages such as Shan is required.
- Excellent administrative, time management and organizational skills.
- Upholds a high sense of accountability, professionalism and confidentiality.
- Advanced computer proficiency especially in MS Office suite.
- Fosters collaboration, creativity, positivity and flexibility in the workplace.
