PURPOSE OF THE ROLE

The purpose of this position is to ensure the provision of technical advice and substantive support to CARE Myanmar in the area of monitoring, evaluation, learning and accountability under the supervision of MEAL Advisor.

This position may be required to travel to project implementation areas.

MAIN RESPONSIBILITIES

MONITORING, EVALUATION, ACCOUNTABILITY AND LEARNING (MEAL) 30% of time

- Apply technical skills and expertise in monitoring, evaluation, learning and accountability to support the successful development and implementation of EQ project;
- Support in the development, refinement, compilation and review of M&E systems and tools including the EQ database;
- Conduct regular monitoring, PDM of project activities with collaboration with partners;

- Ensures that monitoring, evaluation, learning and accountability data is used throughout the project management cycle to continually improve CARE's EQ project;
- Support the organization and facilitation of project reflections and evaluations of project activities; and
- Provide feedback on EQ project activities to CARE Myanmar, project partners, communities, and other stakeholders.
- With the support of EQ MEAL Advisors, assess partners' field level M&E systems, and provide necessary technical support;
- Participate and support technical studies and assessment/ surveys conducted by the EQ project
