CPM has nearly 10 years of experience in building the skills and resources of local partners (including faith-based organizations, local NGOs, community-based organizations, and ethnic health organizations). Currently, CPM is working together with Community-Based Organizations (CBOs) and Civil Society Organizations (CSOs) for delivering primary health care services, education, livelihood, and community development services in sub-urban areas and remote areas.

CPM is looking for a qualified candidate to support the program and partnership management of the HIV/TB project. The Program Coordinator (HIV/TB) will work closely with the program team and Program Manager (HIV/TB) to ensure that all the activities implemented are in timeline and donor requirements. This is a unique opportunity to gain valuable experience and provide technical and strategic support for HIV/AIDS and TB prevention and care projects in Myanmar.

## Primary Responsibilities

- Collaborate and communicate effectively with partners and relevant organizations to facilitate the execution of HIV/TB-related initiatives, offering necessary technical and administrative assistance to partner organizations.
- Foster and maintain strong relationships with partners, local stakeholders, and other relevant organizations, ensuring efficient coordination.
- Assist partners in devising work plans and executing project activities targeted at Key Populations and TB risk populations in high burden areas.
- Evaluate and revise HIV/TB technical recommendations as needed, and prepare concise briefs outlining the rationale. Apply these recommendations during the review of implementing partners' proposed concept notes and work plans.
- Monitor partner organizations to ensure adherence to the agreed-upon technical plan and effective implementation.

- Collect and review monthly reports from partners, providing prompt feedback and necessary guidance with minimal supervision.
- Collaborate with the Program Manager and program team to prepare comprehensive donor reports on HIV/TB activities.
- Evaluate needs and conduct regular site visits to assess the requirements and provide training based on the observations made during the visits.
- Assist the program manager for the overall management of ART team.
- Perform additional tasks as assigned by the program manager.
