Main purpose of the role

Under direct supervision of Medical Team Leader, the role holder will be responsible for the successful delivery of primary health care and SRH services to earthquake affected communities; by assisting Medical Team Leader and collaborating with mobile team members.

Key Responsibilities

Accountability and Complexity

- Responsible of implementing and following up the community health promotion and education
 activities, including the training and facilitation to different groups, along the health educators' team,
 supervising their activities and collaborating on the materials production.
- To ensure strict adherence to universal precautions in health centres and during the mobile clinics
- Ensure proper records of patient's history kept on file and confidentially.
- Ensure appropriate documentation and record keeping of all patient data.
- Ensures that behavior inside and outside of work promotes the values in RI's code of conduct and safeguarding policies

Medical Care

- Lead and perform nursing care, activities and procedures according to RI SOPs and guidelines to
 ensure getting quality of health care services.
- Perform and manage patients flow in clinic triage according to the Relief International guideline and the patients' condition when required.
- Closely work with the midwife on the implementation of PHC, SRH and MNCH services if required.
- Assist in home Based Care and other outreach activities.
- Identify and report cases in need of referral during the community activities.
- Assist the patients during referral to other health facilities if required.
- Lead health education session by collaborating with midwife and health promoter

Infection Control

- To follow and ensure the maintenance of clinic hygiene
- To follow Universal Precaution and proper waste management as per RI and international

Pharmacy Management

- To do monthly physical stock count.
- To ensure refilling minimal stock balance for every mobile visits.

Reporting and Trainings

- To lead the health education teams and design health education activities
- Design the IEC materials with input from the team and beneficiaries.
- Keep proper records and registers, including data entry of the activities implemented
- Participate and assist in training initiatives.

Communication and Coordination

- To maintain good relationship with all staff, implementing partner mobile teams and camp committee members.
- Coordinate with referral focal to refer the patients who needed other health facilities if required.
- To take part in program meeting, program review and in general staff meetings
- To closely collaborate with other RI teams, especially Protection.
- To deal with community focal point/assigned BHS/ Local authorities/ CBOs and CSO for timely patient referral.
- To facilitate the field activities such as kit distribution with other implementing teams and partners.

- Basic English and Myanmar language.
- Ability to speak local languages (desirable)
- Flexible and empathetic attitude
- Able to manage pharmacy items and dispensary management daily, weekly and monthly.
- Good communication skills between the clients and staff and among the team.
- Able to work under little supervision to complete tasks with timely manner.
