- Proficiency in one or more ethnic minority language (s) is preferred.
- Ability to work independently and proactively, as well as under the supervision of a Research Manager
- Ability to handle multiple tasks simultaneously and work at times against difficult deadlines
- Excellent interpersonal skills and ability to communicate and work well in a team
- Ability to develop good relationships with various stakeholders
- Willing and able to travel to ethnic areas in the country (and, if needed, foreign countries) to carry out assigned works
