The GPE-ESPIG project grant is to provide the necessary student kits for children who are experiencing difficulties so that they can continue their education. This support is to support children to continue learning and to address their parents in a social economic of another way. The items will be based on the results of the assessment and information provided by the relevant stakeholders and children from the targeted areas. Based on that, Shwe Kyun Thar aims to provide raincoats and BPA-free water bottles in 45 Schools in Mon State, and this is a process to identify the potential supplier to provide the mentioned items as per the project work plan.

- 1. All the goods are for a humanitarian project in MON State, Myanmar, an intervention supported by the GPE (Global Partnership for Education) through the SCI's technical support.
- 2. All goods are to be delivered to SKT Thaton Office, Mon Sate, or a designated place according to the contract.
- 3. The offer prices shall be quoted in Myanmar Kyats only.
- 4. All offers, in English Language only, must be delivered to the office mentioned below by 18th March 2025 (5:00 PM).
- 5. The deadline for submitting is 18 March 2025, and late bidding will be rejected.
- 6. Quotation will be opened at the address mentioned below at the time stated in the quotation Dossier. The candidate or their authorized representative can be present at the opening of quotations, or SKT will inform the selected supplier.

Assurance by the Supplier

Submission of Documents by the Supplier

- □ Suppliers need to provide company information and related legislation documents to review for further process
- Suppliers need to provide partner organization's information as referee
