OVERVIEW OF THE FUNCTIONS OF THE POST

1. Background:

Under the Global Partnership for Education (GPE) Education Sector Program Implementation Grant (ESPIG), UNESCO is implementing activities towards the attainment of the undermentioned three outcome areas.

- Outcome 1: Ensuring safe and equitable access to learning for children and youth in Myanmar;
- Outcome 2: Ensuring quality teaching and learning for children and youth in Myanmar by strengthening the capacities of education staff and fostering context-responsive, equity-focused learning resources and modalities adapted to the evolving situation; and
- Outcome 3: Ensuring systems strengthening, management, coordination, and monitoring.

Through the ESPIG program, UNESCO aims to address the needs of both pre-service and inservice teacher education under ESPIG Outcome Area 2: Ensuring quality teaching and learning for children and youths in Myanmar by strengthening the capacities of education staff and fostering context-responsive, equity-focused learning resources and modalities adapted to the evolving situation. However, many educators serving in these challenging contexts are new to the profession and they may struggle to deliver effective instruction, provide psychosocial support and create safe learning environments. Equipping educators with the right skills, methodologies and resources strengthens their ability to foster resilience in students, ensure inclusive learning and uphold quality education standards. To initiate this, UNESCO brings Myanmar Teacher Platform (MTP; www.mmteacherplatform.net) to offer continuous learning for educators, learners and other interested parties to access quality learning materials, videos and other resources in a safe and secure environment and

provide online courses by themes.

In response to growing educational needs, UNESCO is committed to support continued professional development for all types of educators through different channels. In 2022, UNESCO Myanmar launched the Myanmar Teacher platform (MTP), which provides educators, learners and other interested parties to provide quality learning materials, videos and resources in a safe and secure environment. To foster professional network for educators in Myanmar, UNESCO has established professional learning groups on MTP creating a safe and inclusive space for dialogue on four educational themes such as literacy, numeracy, pedagogy and ICT and another two groups will be extended to set up in the last quarter of 2025. In these groups, learning activities and events such as webinar/workshop are occasionally organized for the group members to update their professional knowledge in related themes and engage in academic discussions and learning activities. Additionally, UNESCO also aims to promote peer learning and communities of practices among teachers sharing professional experience, challenges and best teaching practices.

2. PURPOSE OF THE ASSIGNMENT

The Individual Specialist is sought to design engaging and effective learning activities and events, develop relevant contents, facilitate within the groups, encourage group participation and monitor the learning progress of the groups, working closely with UNESCO Education team to build a dynamic and supportive educational community, ensuring an enjoyable learning experience for educators.

3. DUTIES AND RESPONSIBILITIES

Supervisory arrangements:

Under the overall authority of the Regional Director of the United Nations Educational Scientific and Cultural Organization (UNESCO) Regional Office in Bangkok, the direct supervision of Head of UNESCO Yangon Antenna, in close collaboration with the Education Sector Program Implementation Grant (ESPIG) teams, the Individual Specialist is sought to create learning activities/events, facilitate the group members for better engagement and monitor learning progress of the members through performing the following tasks.

Terms of Reference:

- Discuss with UNESCO education team to map out the topics and timeline for learning activities and events for each group (including but not limited to literacy, numeracy, ICT and Pedagogy);
- Conduct a preliminary needs assessment to understand the interest of group member, priorities and learning needs;
- Design and create engaging learning activities, quizzes and exercises to promote active participation and learning within the groups;

- Familiarize the tools of professional learning groups from MPT and develop engagement strategies such as interactive polls, games and peer discussions;
- Review the resources from MTP and other reliable sources to create content such as
 posts and short videos to stimulate curiosity, enthusiasm and reflection on related
 themes in the groups and feedback/response to the query or provide
 feedback/suggestion on the groups;
- Upload the relevant announcements and posts on related Thematic Groups to keep the group members informed;
- Ensure that no plagiarized or self-plagiarized materials are published without appropriate acknowledgement of the source;
- Prepare and organize the learning events (training/webinar/workshop);
- Proactively identify and engage relevant resource persons to participate in learning events;
- Collaborate with resource persons to ensure presentation materials align with the event objectives and the level of the audiences;
- Moderate online learning activities and events and facilitate Q&A sessions and discussions, ensuring active engagement;
- Encourage participation, discussions, and knowledge sharing among members;
- Prepare relevant assessments and analyze participant feedback to prepare report of the events, including key takeaways, challenges and recommendations;
- Participate and contribute at the weekly meeting and provide the updated information; and
- Keep an up-to-date, daily record of the work online and make it available for UNESCO to oversee the progress.

In line with UNESCO's overall gender mainstreaming strategy, the individual specialist is expected to integrate a gender perspective in all activities and apply gender analysis and mainstreaming concepts whenever feasible.

Travel:

• The Individual Specialist will be based in UNESCO Antenna Office in Yangon during the contract period. No travel outside Yangon is anticipated.
