**POSITION SUMMARY**: The Project Coordinator will be responsible for planning, coordinating, implementing, and monitoring an integrated project focusing on Primary Health Care (PHC), Sexual and Reproductive Health and Rights (SRHR), and Gender-Based Violence (GBV) interventions. The position will ensure high-quality service delivery through mobile clinics, awareness sessions, capacity-building initiatives, referral support mechanisms, and advocacy campaigns in both humanitarian and development settings. This role includes close coordination with stakeholders, field teams, service providers, and partners.

### **Key Responsibilities:**

- Coordinate the implementation of all project activities, including:
  - o PHC and SRHR awareness-raising sessions
  - o Midwifery-led SRHR mobile clinics
  - o Emergency referral support (EmOC-60, ECC-60)
  - o Adolescent and youth SRHR education
  - o GBV awareness-raising and response services
  - O Distribution of dignity kits to IDPs and other vulnerable groups
- Ensure timely implementation according to the project work plan and budget.
- Oversee effective delivery of SRHR capacity-building trainings (ANC/PNC, FP, BeMOC, CMR, MISP, PAC).
- Coordinate and manage referrals for GBV survivors and persons with disabilities (PWDs) or conflict-affected victims.
- Supervise and support field teams, including health providers, mobilizers, and trainers.
- Facilitate regular team meetings to review progress, address challenges, and maintain high motivation and performance standards.
- Work with the M&E team to develop and track key performance indicators.
- Collect and compile field data, success stories, and progress reports for internal and donor reporting.
