### **Duties & Responsibilities**

The job of the Civil Engineer includes the following duties and responsibilities:

- Work under the supervision of the Shan Program Manager, and in close coordination with the Logistic Officer to ensure all construction-related activities, particularly those including water supply systems, shelters and sanitation facilities, are implemented in line with the approved project plan.
- Guide and mentor for construction works and coordinate the field activities with the team members.
- Assist, advise, and coordinate with the Shan Program Manager and WASH engineer with regards to the appropriateness of the related technical options.
- Determine the availability of local technical service providers for infrastructure related activities.
- Provide and facilitate in-house and community level training as required.
- Provide any required information to the SPM in order to ensure timely provision of funds or technical training in support of infrastructure activities.
- Monitor and supervise the execution of works at all infrastructure activities in the project area
  through site visits using relevant construction monitoring and inspection check lists, in order to
  follow up the progress of the works and ensure their conformity with the drawings, contract
  documents, acceptable engineering practices and the terms and conditions of the contract
  agreement.
- Secure a construction process that complies with the contractual documents (BoQ, Design) and is carried out according to the set standards and agreements.
- Quality control of the construction work and used construction material (inspection of material used and their workmanship).
- Liaise and maintain a close working relationship with the relevant communities in construction sites to support their participation and own monitoring by providing information on technical options and relative design, specification and costs.
- Ensure that the project activities remain linked and relevant to the satisfaction of minimum needs and are accessible to the vulnerable members of the community.

- Liaise and maintain a close working relationship with the related government departments such as Township Education Department.
- Provide relevant assessment reports and data to the SPM
- Develop work plans in close cooperation with the SPM.
- Responsible for trouble shooting related to the construction work.
- Provide monthly construction progress reports using the provided templates.
- Perform other tasks that may be required by the Shan Program Manager.
- Work closely with other teams & ensure holistic project

#### **Position Requirements**

- Engineering degree in Civil or Diploma in Civil plus comparable working experience in the construction sector.
- At least 3 years of relevant working experience, ideally in development and or humanitarian project.
- Working experience in Emergency response is an advantage
- Working experience in school construction, installing water supply system and the construction of WASH (Water Supply and Sanitation) facilities for rural and IDP camp is essential. And also experience in assessments of WASH in school and community
- Experience with tender selection process and transparent procurement principles
- Good understanding of the local context in the project area and willingness to travel to the field
- Experience in engaging and liaising with communities, sub-contracting companies and government departments
- Experience in conducting O&M training to communities is in advantage.
- Experience in inspection and monitoring of construction for quality control.
- Proven reporting and monitoring skill
- English skill (oral and written) is in advantage.
- Relevant IT and management skill
- Knowledge of technical drawing software
- Good interpersonal skills
- Good communication and leadership skills
