## Primary Responsibilities

- Responsible to ensure quotation and information from a wide range of supplies and vendors are obtained, even though it is emergency response program.
- Ensure procurement plans are developed and regularly updated for emergency response projects.
- Work closely with program responsible to ensure necessary logistics data are obtained and reports are produced in accordance with donor requirements.

- Provide technical support to CPI's field offices in consultation with supervisor

- Provide orientation and training support to Partners on stock management, and Procurement & Logistics activities to ensure compliance with donor Guidelines.
- Follow up and monitor Partners' procurement process as per their and donor guidelines.
- Support in developing inventory control system & maintaining minimum medical stock levels of CPI local partners.
- Evaluate the drug stock management system of the partners and provide technical inputs for improvement and ensure adaptation of good practices.
- Carry out the duties in a manner of promoting equity and showing due respect for all CPI's local partners by understanding their norms, culture and local context.
