#### **PURPOSE OF THE POSITION**

The Project Officer is to coordinate and support the effective implementation of activities across key thematic areas—Emergency Response, Humanitarian Mine Action, Environment and Climate Change, Disability Inclusion, and Mental Health and Psychosocial Support (MHPSS) project activities. The role ensures that project interventions are timely, inclusive, and aligned with community needs, while promoting safety, resilience, sustainability, and the well-being of vulnerable populations.

#### **DUTIES AND RESPONSIBILITIES**

- Coordinate and implement project activities related to Humanitarian Mine Action, including risk education sessions, victim assistance support, and community safety awareness.
- Integrate climate resilience and sustainable environmental practices into project planning and field activities.
- Support emergency preparedness and response efforts by ensuring timely delivery of humanitarian aid and recovery support to affected communities.
- Promote disability inclusion by ensuring accessibility, participation, and representation of persons with disabilities in all project components.
- Facilitate mental health and psychosocial support (MHPSS) activities, including community-based support and referrals to specialized services.
- Monitor and report on project progress, ensuring quality implementation, documentation, and compliance with donor and organizational standards.
- Build and maintain strong relationships with local communities, stakeholders, and partners to support collaborative and inclusive project delivery.
- Contribute to data collection, needs assessments, and learning processes to inform ongoing improvements and strategic planning.
